**CIMB group - bu osiyaning yetakchi universal banki va mintaqaning eng yirik korporativ maslahatchilaridan biri.**

Bu Osiyodagi aktivlari bo'yicha beshinchi yirik bank guruhi bo'lib, 2020 yil dekabr oyi oxiriga kelib 34 mingga yaqin xodim va 16 milliondan ortiq mijozga ega edi.

U islomiy moliya sohasida dunyoda etakchi o'rinni egallaydi. Guruhning shtab-kvartirasi malayziyaning kuala-lumpur shahrida joylashgan bo'lib, iste'mol banklari, tijorat banklari, investitsiya banklari, islam banklari va aktivlarni boshqarish bo'yicha mahsulotlar va xizmatlarni taklif etadi.

# Tarixi:

- 1974 yil. Pertanian Baring Sanwa ko'p millatli banki (PBSM) kuala-lumpurda tashkil etilgan va bosh vazir Tun Abdul Rozak Xuseyn tomonidan boshlangan.
- 1986 yil. PBSM, savdo banki tomonidan sotib olingandan so'ng, o'z nomini commerce international merchant bankers berhad (CIMB) deb o'zgartirdi.
- 2003 yil. CIMB ro'yxati malayziyaning bursa shahri. Listing atigi uch yil davom etadi va aksiyadorlarga 340% daromad keltiradi.
- 2005 yil. CIMB islamic 2005 yil 6 iyunda tijari bank bilan tijorat bankiga qo'shildi.
- 2010 yil. Bitta rangli platformaga o'tish uchun CIMB group brendini uyg'unlashtirish mashqlari, endi CIMB islamic logo qizil rangga ega.




## Yearly Earnings Trend




**GROSS LOANS**  
(RM'000)




**DEPOSITS FROM CUSTOMERS<sup>^</sup>**


**ROE**  
(%)




**GROSS DIVIDEND PER SHARE**
